# SCHOOL - TRANSPORTATION

## TERMS AND CONDITIONS

1. The transportation fee will be collected in advance along with the school fee.
2. The fees once paid will not be refunded or adjusted.
3. There will be no rebate or concession for one way use of bus.
4. The transport form is required to be signed by transport in charge to confirm the availability of transport.
5. Any change of location must be informed to the office or to transport in charge minimum one week before. Please fill in the prescribed form which is available in the school office for new location. Change of location request will be subjected to the availability of the service & seats. Previous ID card of the child to be submitted to the transport supervisor. Only then the new ID card will be issued.
6. The school management has right to reconsider the transportation charges according to the location, services, and hike in fuel cost.
7. Students proceeding on leave will have to pay the transportation fee for the period of leave; however, if such a period is taken for a full term, the transportation fee may be waived off. Once the name is enrolled for us transport, request for discontinuation will be entertained only with application prior to the commencement of the next term.
8. The transportation will be available on the routes chartered by the school at the beginning of the year; however the routes may be changed for genuine reasons.
9. The school cannot take any responsibility of delay due to traffic surprises.
10. Transport will not be provided to a different drop off point other than the pickup point.
11. For security reasons, students should be accompanied by an adult to and from the bus stop. The parents/guardians must wait at the picking-up and dropping off points prior to the time agreed.
12. Students will be picked up and dropped off at a common bus stop, which will be designated by the school authority.
13. The buses will not wait for the late comers.
14. The students should stay away from the main road until the bus arrives.
15. All students must occupy seats immediately after boarding their buses.
16. Students will not be allowed to board another bus at their choosing.
17. The bus conductors are responsible for maintain discipline in the buses & serious offences will be reported to the Principal.
18. The drivers are authorized to stop buses only at the designated stop, the stopping points are fixed on the basis of convenience, traffic rules and safety precautions.
19. The driver's attention must not be distracted for any reason.
20. The students should come to the entry/exit door only after bus has made a complete stop.
21. Discarding of trash or food either inside or outside buses is not permitted.
22. Students are not allowed to eat in the bus.
23. Students will be held responsible for any damage to buses caused by negligence or vandalism, and parents would bear the cost of the same.
24. Courteous behavior is expected at all times from the students.
25. The transportation will be cancelled with immediate effect as a result of student's misbehavior/misconduct in the school bus.
26. Student without ID will be not picked up or dropped off by the school transport.
27. If the student's location is very remote or considered hard to reach/children will be dropped at the nearest land mark given by concerned transport authority.
28. If the parent/guardian is not available at the drop off point, the child will be brought back to the Play School, later parents will have to pick-up the child from the school
